TOWN WARRANT.

Commonwealth of Massachusetts.

HAMPSHIRE, SS.

To H. H. Prentice, Constable of the GREETING:

In the name of the Commonwealth of Massachusetts, you are directed to notify the inhabitants of the town of Middlefield, qualified to vote in town affairs, to meet at the town hall in said Middlefield, on Monday, the fourth day of March, next, at ten o'clock, in the forenoon, then and there to act on the following articles, to wit:

ARTICLE. 1. To choose a moderator.

ART. 2. To choose, under Chapter 386, Acts of 1890, and the amendments thereof, a town clerk, a town treasurer, three selectmen, two constables, a collector of taxes and a tree warden for the term of one year, a road commissioner, a school committee and a trustee of the public library for the term of three years; also to vote "Yes" or, "No" in answer to the question, "Shall licenses be granted for the sale of intoxicating liquors in this town?" The polls will be opened at thirty minutes past ten o'clock, A. M., and may be closed at thirty minutes past two o'clock, P. M.

ART. 3. To hear the reports of the selectmen, assessors, overseers of the poor and school committee, and act thereon.

ART. 4. To choose such town officers as are not required by law to be chosen by ballot.

ART. 5. To raise and appropriate such sums of money as may be necessary to defray town expenses for the current year.

ART. 6. To determine the disposition of the dog fund.

ART. 7. To determine the manner of collecting the taxes and to fix the compensation of the collector of taxes.

ART. 8. To see if the town will accept the list of jurors as proposed by the selectmen.

ART. 9. To transact any other business that may legally come before said meeting.

And you are directed to serve this warrant by posting up attested copies thereof at each of the postoffices in said Middlefield, seven days, at least, before the time for holding said meeting.

Hereof fail not, and make due return of this warrant, with your doings thereon, to the town clerk, at or before the time for holding said meeting.
