1. Lots shall be used only as a burial place for the dead. All burials therein shall be subject to the regulations established by any board of the Cemetery Commissioners elected by the Town of Middlefield, or to any set of by-laws adopted by the town.
2. Owners of lots must notify the clerk of the Cemetery Commissioners within ten days, of the resale of any lot, stating the date of resale and the person to whom the lot was sold.
3. Owners of their lots, their heirs and assigns, shall have the right to erect stones or monuments thereon, and to cultivate thereon only plants and flowers; no trees or shrubs may be planted.
4. No tombs shall be constructed in or upon any lot or lots in said cemetery.
5. If any tree, shrub or plant in any lot, by reason of its roots or branches shall, in the opinion of the commissioners, become detrimental to said lot or to any adjacent lot, walk or avenue, such tree plant or shrub may be removed at any time by the commissioners aforesaid.
6. The grading of any lot shall not exceed six inches above the normal level.
